- #SafeDrivesSaveLivesVT PSA Contest: Sue reviewed activities to date. We've received record sponsorship at \$4,100. Sue will distribute a proposed prize hierarchy to the planning committee.
- Impaired Driving Summit:
  - The summit will proceed as an in-person event
  - Email reminder will be sent to pre-registered attendees who signed up for Fall 2021 date
  - o Likely that the VDTSEA attendees will attend virtually
  - o Sue to research hybrid options and associated costs
  - Agreed to permanently move annual conference to spring
  - Recognition awards for VHSA board members will continue at annual conference

- Still waiting for some data on 2021 fatalities. Numbers of unbelted, impaired, speeding, and total number of fatalities all higher than previous years.

- Local Motion: Mary-Catherine Graziano. Just ran a winter walk to school day event on February 2nd to encourage students to be outside. Events through March. Over 30 schools participating this year.
- VDH: Alexandra. Working closing with many partners for the Walk/Bike Summit. Extended date for proposal to present. Opportunities for Law Enforcement at the summit. GHSA sent out announcement about deaths rising across the country. Webinar on Safe Systems approach is coming out. CPS group has set up two classes this year—Vergennes and St. Albans. - DMV Enforcement: Pat McManaman. Justin McLane now the new contact for driver educators and schools. Adding the advanced rider course to the curriculum for the spring. RE: CDL drivers. There is a pilot project for CDL drivers for younger drivers 18 to 21. Pilot states are issuing licenses without restrictions for driving intrastate (18 to 21 year olds) Looking to fill driver shortages
