Lt. Al Fortin reported on the checkpoint and saturation patrols in St. Albans for Super Bowl Sunday.

Barb Brody reported that the Vermont Driver Educators Conference is May 20th at Vermont Technical Center in Randolph. Partners are invited to attend and/or table. For tabling, they will not charge organizations an exhibit fee, only a meal charge to cover our meal expenses. The VDTSEA hopes for partners to exhibit materials and information for our Driver Education Teachers to bring back to their schools or businesses. Ted Minall, Federal Updates. Maine is legalizing marijuana, and New York is also on their way to legalizing recreational marijuana, which is important because of relative proximity to VT. Also, all three of Rhode Island's fatalities, this year, have been pedestrians and that's raising an alarm There is movement afoot in NY to go to .05 with strong backing.

There is a speed reduction campaign planned for July with Region-1 States. The tag line for the R-1, six state (including CT) July 2020, Speed Reduction Campaign will be "When speed kills, it's never an accident". There is an effort to secure proclamations of support from each of the 6 states' Chiefs/Sheriffs Associations.
